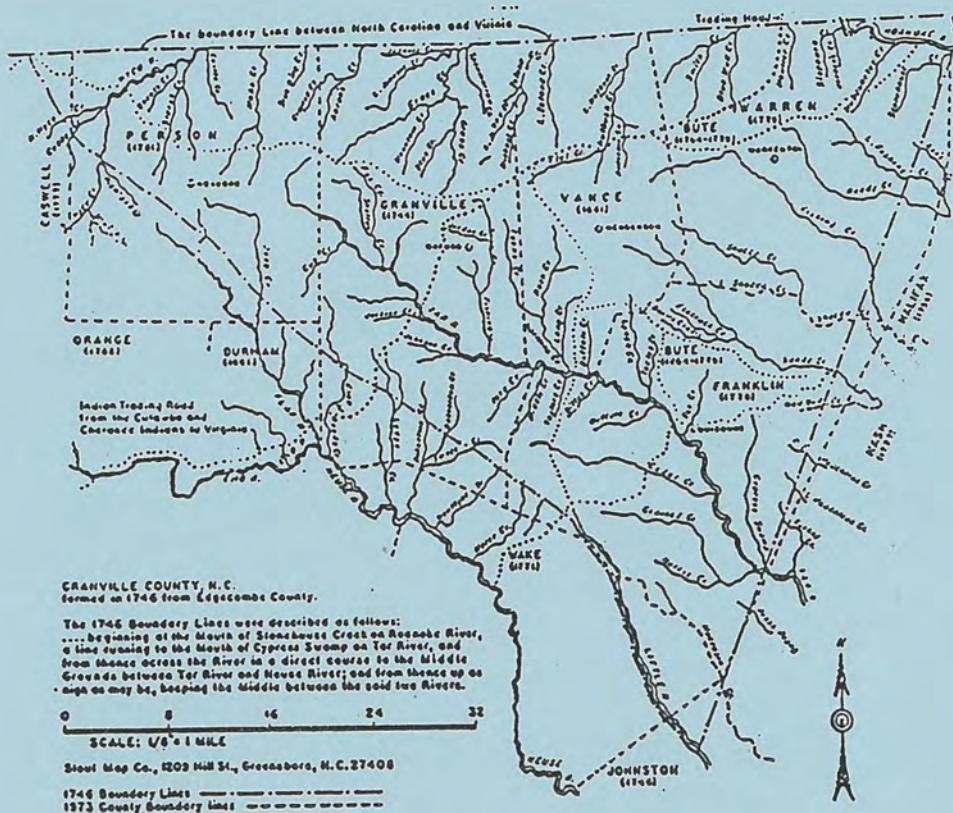

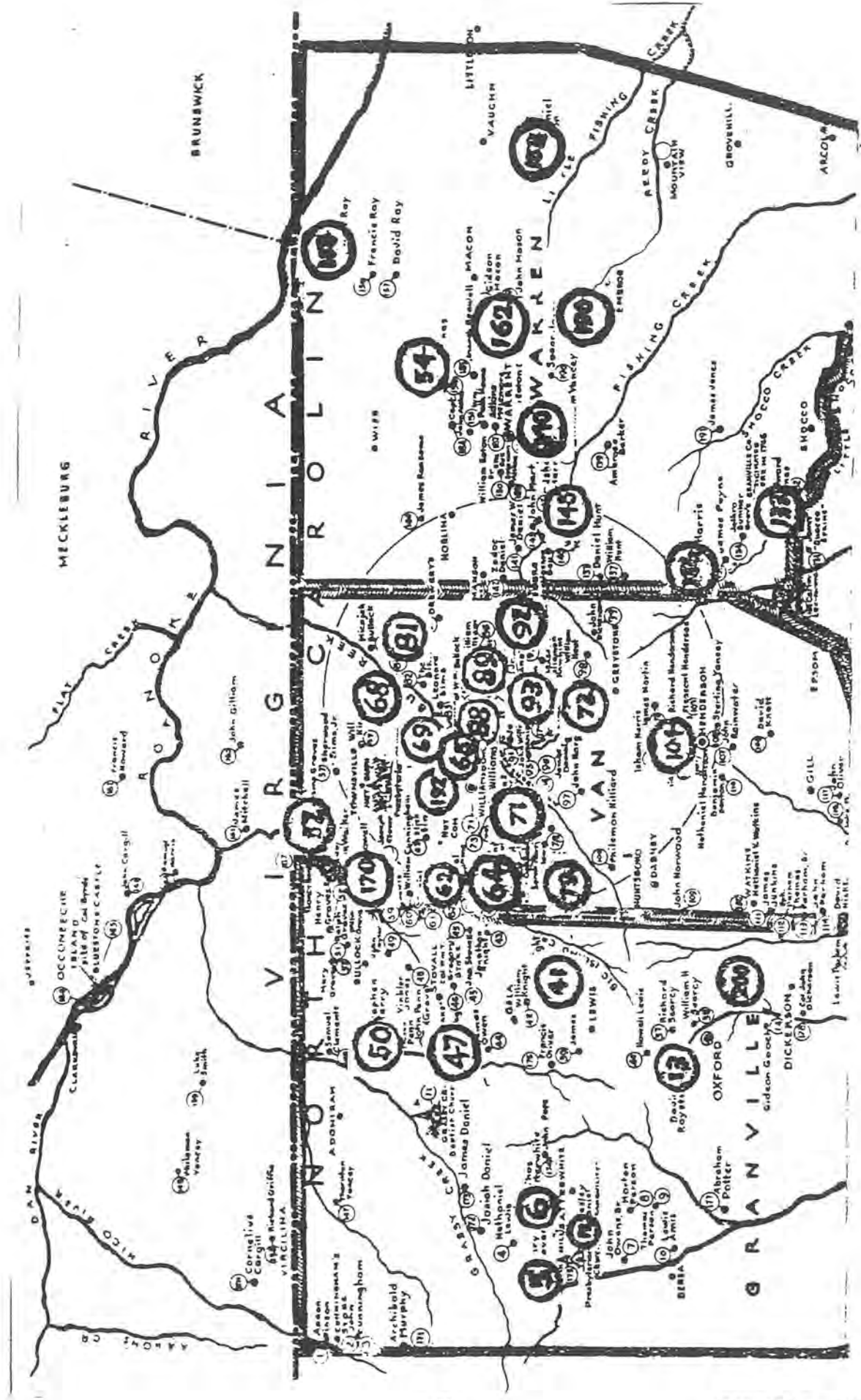

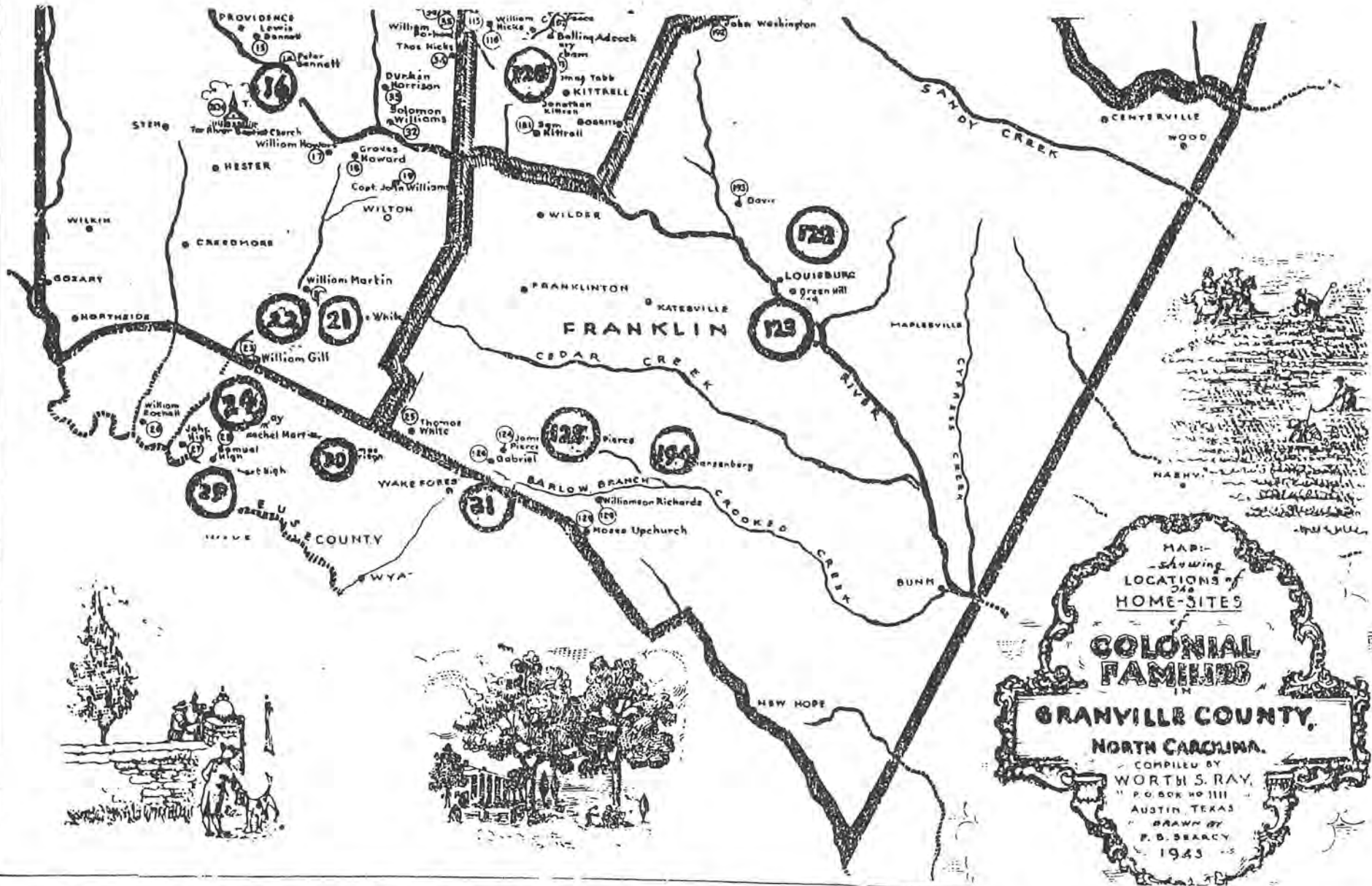
Searcy Map Showing Locations of Home-Sites of Colonial Families in Granville County

Black North Carolina Confederate Pensioners

[Editor's Introduction: In the vast literature regarding the Civil War, black men in Confederate service have received little attention. However North Carolina records do identify some of those men.

In March 1927 the North Carolina General Assembly amended the statutes relative to Confederate Pensions and provided for payment of \$200.00 per year "to such colored servants who went with their masters to the war and can prove their service to the satisfaction of the county and State pension boards,..." (*Public Laws of North Carolina, 1927*, Chapter 96) Applications for pensions came not only from wartime body servants, but also from those who had served Confederate forces as cooks, washers, laborers, teamsters, and constructors of breastworks. Most of these men had been slaves before the War, but there were some who had been free before Emancipation. The records below reveal a few black men who had actually enlisted in the Confederate Army.

Mr. **KOONTS** has rendered a valuable service to genealogists and historians by extracting the items below from the applications for Confederate Pensions in the North Carolina State Archives, Raleigh, North Carolina.]

John **JOHNSON** (Wilson County). One widows' application for Lula **JOHNSON**; veteran served in the 14th Regt. U. S. Colored Heavy Artillery (1st N. C. Colored Heavy Artillery); soldier also went by the name John **STREETER**.

Jacob **JONES** (Guilford County). Applicant is a former slave who acted as a body servant to his master, Colonel E. P. **JONES**.

Joseph **JONES** (Guilford County). Applicant is a black man who served under Quartermaster Thomas **SLOAN** in Greensboro.

Stokes **JUDD** (Lee County). Veteran is a black man who acted as a body servant to Captain **DAVIS**.

George W. **KENDALL** (Stanly County). Applicant is a former slave of Reuben **KENDALL** who served as a laborer and a teamster at Ft. Fisher.

Weldon **KENDALL** (Anson County). Applicant is a former slave who was a body servant to his master, Henry **KENDALL**.

D. R. **KENNEDY** (Gaston County). Applicant is a former slave who was a servant to William **MCCLURE** of the South Carolina State Troops.

Adam **KING** (Cleveland County). Applicant is a former slave who acted as a servant to his master, Frank **LOVE** of York, South Carolina.

Press **LEDBETTER** (Anson County). Applicant was a former slave of Colonel Henry W. **LEDBETTER** who was sent to Fort Fisher under H. B. **BILLINGSLEY**.

Grand **LEWIS** (Vance County). Applicant is a former slave of James **COOPER** who was a body servant of David **COOPER** during the war.

Will **LIGGINS** (Alamance County). Applicant was a former slave who acted as a servant to Colonel James E. **BOYD**, Clay **HAZELL**, and Jim **VINCENT**.

Lewis **LILLY** (Robeson County). Applicant was a former slave who acted as a body servant to his master, Robert **LILLY**.

Peter M. **LOVE** (Gaston County). Applicant is a former slave who acted as a servant to R. G. **LOVE**.

Caleb **LOWDER, Sr.** (Lincoln County). One soldiers' application; one widows' application for Fannie **LOWDER**; applicant is a black man who enlisted as a cook under Robert **HOKE**; name also given as Caleb **LAUDER**.

J. M. **MCDANIEL** (Randolph County). Applicant is a black man who was sent to Wilmington to load and unload freight cars.

Fred **MCDOWELL** (Bladen County). Applicant was a black man who served under Captain **MIDDLETON** during the building of Fort Fisher.

Frank **MCGHEE** (Granville County). Applicant is a black man who acted as a body servant to Captain Richard P. **TAYLOR**.

Lewis **MCGILL** (Union County). Applicant was a former slave who acted as a body servant to his master, Ellis **FRAZIER**, in the South Carolina State Troops.

Henry Clay **MCKNIGHT** (Franklin County). Applicant was a former slave of Alexander **MCKNIGHT**, who was sent to help construct breastworks in Virginia.

Isaac **MCLELLAND** (Iredell County). Applicant was a former slave who went to war with his masters, John **MCLELLAND** and Fess **MCLELLAND**.

Bill **MCMILLAN** (Duplin County). Applicant is a former slave of John C. **MCMILLAN** who acted as a cook and servant for his master. applicant also goes by the name Bill **STALLINGS**.

William **MAJORS** (Person County). Applicant was a former slave who acted as a body servant to his master, Sam **MAJORS**.

Oscar **MASSENBURG** (Wake County). Applicant is a black man who served as a teamster during the war; affidavit from John **THOMAS**, a black man who served during the war.

George W. **MAYNOR** (Harnett County). Applicant is a free black man who helped construct breastworks at Fort Caswell and Fort Fisher.

M. H. **MENDENHALL** (Anson County). Applicant is a former slave who acted as a body servant to his master, W. A. **MENDENHALL**.

William **MILLER** (Rockingham County). Applicant is a former slave of veteran Daniel E. **GUERRANT** who went to Wilmington to help construct breastworks; applicant is also known by the name Bill **MILLER**.

Adam **MOORE** (Lincoln County). Applicant is a former slave of Moses **ROBERTS** who was sent by his master to serve as a wagoner; deposition contains some information on slave's early life.

Redic **MORRISETTE** (Camden County). Two soldiers' applications; applicant is a black man who served as a cook.

Anderson G. **NELSON** (Guilford County). Applicant is a former slave, who, along with his father Alex **NELSON**, acted as body guards and servants to their master Isaac **NELSON**.

John **NORTON** (Anson County). Applicant is a former slave who served with his master, Burrell **MERRIMAN**, in the South Carolina State Troops.

Cye **OSBURNE** (Wake County). Applicant is a black man who acted as a body servant to Edwin A. **OSBURNE** and Thomas **OSBURNE**.

Joseph **OWEN** (McDowell County). Applicant is a free black man who was conscripted into the Pioneer Troops.

Buck **PARKER** (Alamance County). Applicant is a former slave who acted as a servant to H. Clay **KING**.

Wiley **PAYTHRESS** (Franklin County). Applicant is a former slave who acted as a servant to his master, Wash **BRANCH**.

Aaron **PERRY** (Union County). Applicant is a former slave who acted as a body servant to his master, Colonel John B. **ASHCROFT**.

Silas **PETTIFORD** (Franklin County). Applicant is a former slave who acted as a body servant to his master, S. C. **BLACKLEY**.

Abner **PHELPS** (Caswell County). Applicant is a former slave.

Frank **PLUMMER** (Granville County). Applicant is a former slave of Dr. Alfred **PLUMMER** who helped build breastworks.

John **POLK** (Lincoln County). Applicant is a black man who acted as a body guard to Colonel Samuel **LOVE**.

Berd **POOL** (Granville County). Applicant is a former slave who served with his master, Amos **POOL**, in the Virginia State Troops.

Milas **POTTS** (Cabarrus County). Applicant is a black man who helped build breastworks around Wilmington.

Amos **POWELL** (Anson County). Applicant is a black man who acted as a body servant to Charles P. **POWELL**.

Malcolm M. **PRINCE** (Wake County). Applicant is a former slave who went to Wilmington with William **PRICE**, son of his master, to help build breastworks.

M. C. **RANSOM** (Granville County). Applicant is a black man who acted as a servant to Captain William **BALLARD**, Lieutenant Henry **KEARNEY**, and Lieutenant John **MORRIS**.

William **RATLIFF** (Anson County). Two soldiers' applications; applicant is a former slave who acted as a cook for his master, Nelson P. **HILDRETH**.

Henry **REED** (Halifax County). Applicant is a black man who acted as a body servant of Dr. Condy **BOYD** and then helped build breastworks.

James **RICE** (Cleveland County). Applicant is a black man who enlisted at Charleston, South Carolina; helped build breastworks at Sullivan Island and Mount Pleasant, South Carolina.

James **RICHARDSON** (Forsyth County). Applicant is a black man who acted as a servant in the Virginia State Troops.

George **ROGERS** (Wake County). Applicant is a former slave who acted as a servant to his master, William **ROGERS**; after his master's death, he helped build breastworks at Natural Gap.

Philip **ROSBORO** (Cleveland County). Applicant is a black man who acted as a servant to Captain John **ROSEBORO** in the South Carolina State Troops.

Frank **RUSSELL** (Cabarrus County). Applicant is a black man who acted as a servant to Captain James **HARRIS**.

David Sellars **SAMSPON** (Sampson County). Applicant is a former slave who acted as a servant to his master, Colonel William **SELLARS**; after his master's death, he worked for Herman **REGISTER** and Henry **LEE**.

Jeff **SANDERS** (Union County). Applicant is a black man who was free prior to the war and served in the South Carolina State Troops under Colonel Ace **EVANS**.

Porter **SCALES** (Rockingham County). Applicant is a black man who helped build breastworks at Fort Fisher.

Jerry **SELLARS** (Alamance County). Applicant is a black man who acted as a servant to James **MOORE** and Captain Joe **TURNER**.

Mat **SMALLWOOD** (Cabarrus County). Applicant is a former slave of Thomas **SMALLWOOD** who hauled provisions to soldiers.

George **SMITH** (Washington County). Applicant is a black man who acted as a body servant to Lieutenant Joseph **SMITH**.

John **SPELMAN** (Camden County). Applicant is a black man who was a cook in Co. A. 56th Regiment N. C. Troops.

Peter **STEWART** (Surry County). Applicant is a black man who enlisted and acted as a servant to David **COOPER**.

Shadrack **STREETER** (Anson County). Applicant is a black man who acted as a servant to Wesley **BATTLE** in the south Carolina State Troops; also helped build breastworks at Frazier's Point.

Aaron **STROWD** (Wake County). Applicant is a former slave of Captain Pinkney **STROWD** who went with his master to Wilmington to build breastworks.

Jack **STUBBS** (Scotland County). Applicant is a former slave of Henry **EASTERLING** who acted as a body servant to his master's son, Robert **EASTERLING**, at Sullivan's Island.

Sam **SWINSON** (Wayne County). Applicant is a former slave who served with his master, John **SWINSON**, at Baldhead Island.

Amos Jones **TAYLOR** (Chatham County). Applicant is a black man who acted as a servant to Captain William H. **JONES**.

Cudge **THOMAS** (Jackson County). Applicant is a former slave who acted as a servant to his master, Colonel William H. **THOMAS**.

John **THOMAS** (Franklin County). Applicant is a black man who acted as a servant to Captain Charles **THOMAS**.

Armstead **THOMPSON** (Orange County). Applicant is a former slave of General Nicholas **THOMPSON**, who helped build breastworks at Wilmington.

Louis **TOMLINSON** (Anson County). Applicant is a former slave of Captain Sam **TOMLINSON**, who helped build breastworks at Wilmington.

Ben **TURNER** (Wake County). Applicant is a former slave who acted as a body guard to his master, Simon S. **TURNER**.

John **TURNER** (Wake County). Applicant is a former slave of Simon S. **TURNER** who hauled provisions.

Thomas **TURNER** (Orange County). Applicant is a black man who manufactured salt petre during the war.

Sandey **UNDERWOOD** (Sampson County). Applicant is a black man who acted as a body servant to Captain Joseph B. **UNDERWOOD**.

John W. **VENABLE** (Forsyth County). Applicant is a black man who was a soldier in Co. H, 21st Regiment N. C. Troops.

Andrew **WALKER** (Washington County). Applicant is a black man who acted as a body servant to Major Benjamin **WALKER**, surgeon.

Brown **WALKER** (Alamance County). Applicant is a black man who acted as a servant to David A. **WALKER**.

Giles **WATSON** (Johnston County). Applicant is a former slave who served with his master, Lieutenant G. W. **WATSON**.

Major Barlett **WELLS** (Jackson County). Applicant is a former slave who served with his master, Captain James **WELLS**, at Fort Sumter.

George **WHITE** (Wake County). Applicant is a former slave of John G. **LAWRENCE** who served with his master's son Ben F. **LAWRENCE**.

Sam **WILKINS** (Gates County). Applicant is a black man who acted as a cook for John **SAVAGE**, and, later, Dr. H. H. **HUNTER** in the Virginia State Troops.

Ed **WILLIAMS** (Gaston County). Applicant is a black man who acted as a servant to Reverend John J. **LANDRUM** in the South Carolina State Troops.

James **WILSON** (Alamance County). Applicant is a black man who enlisted and acted as a cook and attendant to Captain J. W. **LEA** and other Officers of Co. K, 6th Regiment N. C. Troops.

Jerry **WILSON** (Gaston County). Applicant is a black man who acted as a servant to Colonel R. N. **WILSON**.

John **WILSON** (Cabarrus County). Applicant is a black man who acted as a servant to Colonel Tom **BUTLER**.

John **WILSON** (Cleveland County). Applicant is a black man who helped build breastworks at Fort Fisher.

William **WILSON** (Alamance County). Applicant is a black man who served with Lieutenant George **BASON** in the Ordinance Department.

William **WILSON** (Gaston County). Applicant is a black man who acted as body servant to Lieutenant Pinkney **WILSON**.

Houston **WOLFE** (Alleghany County). Applicant is a black man who carried messages for the Home Guard.

Henry H. **YARBOROUGH** (Franklin County). Applicant is a former slave who acted as a servant for his master, Captain R. F. **YARBOROUGH**; also helped build breastworks.

Mark **YOUNG** (Yancey County). Applicant is a black man who acted as a servant to Captain Creed F. **Young** and Wesley **YOUNG**.

Peter **YOUNG** (Mitchell County). Applicant is a former slave who acted as a body servant to his master, Samuel **YOUNG**.

The Last Will and Testament of Archibald P. Montague

It is with a deep feeling of regret, that we are called upon to chronicle the death of Judge A. P. MONTAGUE, which event took place at his home in Cromwell Thursday, April 28, 1881, of consumption. His whole life as a citizen and christian is worthy of example. He leaves a devoted wife and several children who will miss his daily council. His demise will also be deeply felt by the citizens of the town and vicinity in which he lived. - Wednesday, May 4, 1881, The Herald, Hartford, Ky.

In the name of God, Amen, I, Archibald P. **MONTAGUE** of the town of Cromwell and County of Ohio and State of Kentucky, being of sound and disposing memory and mind, and being desirous of settling my worldly affairs while I have strength and capacity so to do, do make and publish this my last will and testament, that is to say: First, I direct that my burial expenses and all of my just debts be paid immediately after my death and burial. Second, I give and bequeath to my beloved wife Nancy E. **MONTAGUE** the house and lot in the town of Cromwell on which I now reside, together with all the household and kitchen furniture, also all of the livestock, buggy and wagon for her use and benefit during her natural life, and at her death to revert to my heirs. In addition I direct that my wife receive out of my estate Five Hundred Dollars in money. Third, The balance of my estate I direct to be equally divided between my six children, Charlie C. **MONTAGUE**, Ettie **MONTAGUE**, Joseph S. **MONTAGUE**, Archibald A. **MONTAGUE**, Edwin A. **MONTAGUE**, and Willie C. **MONTAGUE**. Forth, I direct that my son Charlie C. **MONTAGUE** take charge of my store and proceed to close out all of the goods now on hands and discontinue the business so far as the estate is concerned. Fourth, Whereas George W. **TAYLOR** being indebted to me in the sum of money secured by a mortgage on his farm, I direct that my executors do not proceed to collect the same under two years from the maturity of said mortgage, provided said George W. **TAYLOR** pays the interest on said debt at the end of each year. Fifth, It is my wish that my executors do not urge the collection of safe investments. And lastly, I hereby appoint my wife Nancy E. **MONTAGUE** and Charlie C. **MONTAGUE** my sole Executors, not requiring any bond of them as such. 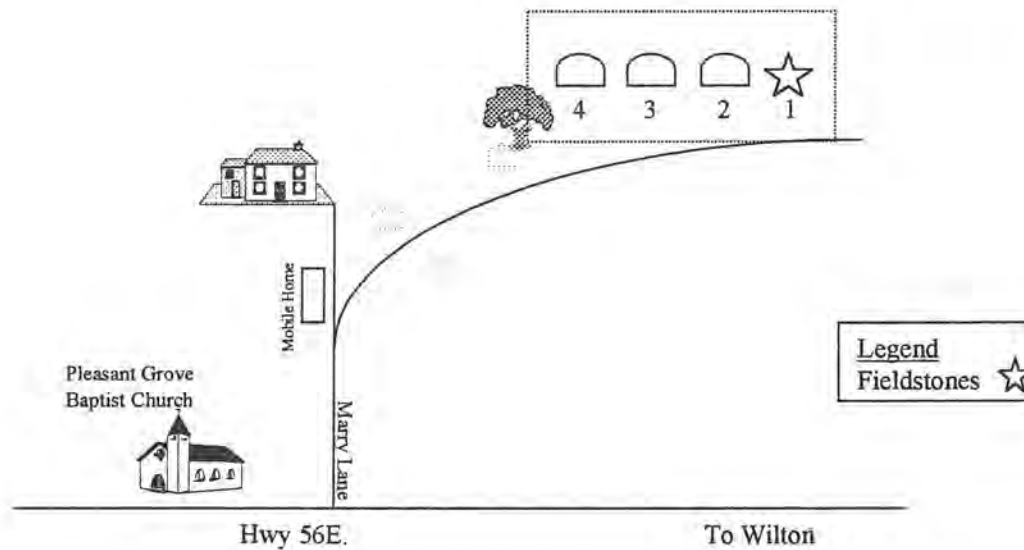

The first U.S. census to be taken as the result of a constitutional provision occurred in 1790. This was done so that representative and direct taxes could be apportioned among the several states that were included in the new United States. It was directed that it should be done within two years and every ten years thereafter.

The first census did just what it was designed to do--it counted the population, but it did that within limited age categories by sex. It also, however, listed the names of the heads of families. This pattern continued until 1840.
